



The Sixth Central Pay Commission has asked IIM Ahmedabad to undertake a study for considering the feasibility for formulation of parameters for **performance related pay** in Government.

2. The study seeks to examine the possibility of direct correlation between performance related pay and delivery of services to citizens/organization/other departments with measurable, quantifiable criteria for judging performance and productivity of different grades of employees in various government organizations. The study aims to develop a model suited to Indian conditions which is transparent, measurable, fosters accountability and is linked to deliverables. It will look at, inter alia, competency, efforts, output, value added measures, productivity measures and consumer satisfaction measures.
