MoD Order

Review of DFPDS-2015

Ref - DFPDS-2015 dated April 20, 2015 and Addendum-1 dated Jun 22, 2015

1. The following has been decided with approval of the RM -
 - 1.1. To constitute a Committee to review DFPDS-15 in consultation with the various stakeholders in a time-bound manner to enable a smooth transition from DFP-2006 to DFPDS-2015 (Encl-1).
 - 1.2. Inherent powers given vide DFPDS-2015, Addendum-1 to DFPDS-2015 and Special Dispensation letters are withdrawn. Inherent powers as per the DFP-2006 for CFAs are restored to the services with immediate effect till completion and acceptance of the report by the Competent authority.
 - 1.3. Enhanced Delegation prescribed vide DFPDS-2015 with concurrence of IFAs will continue till completion and acceptance of the report by the Competent authority. Where IFAs are not posted, such cases may be sent for consideration by the next higher CFA in consultation with his IFA.
 - 1.4. Placement of any additional manpower in IFA set-up may be held in abeyance, which will be assessed only after acceptance of the Committee report.
2. This issues with the concurrence of FA (DS) and approval of RM.

Note Chair may consider constituting sub-committees and co-opting members as deemed appropriate for in-depth examination and for timely completion of the report.

Terms of Reference for the Committee are as under -

- i. To review the amount of inherent powers delegated in 2006 and in 2015 and suggest rationalizations keeping in view the inflation factor, the requirements in the changed scenario or the likely change-scenario in the foreseeable future. The rationalization of inherent powers will be need-based and not a uniform applicability across CFAs/Schedules.
- ii. To review the delegated powers, exercised in consultation with IFAs, promulgated in the DFPDS-2015 and examine if they are need-based and commensurate with the rank/level of CFAs. Across-the-board uniform revision is to be avoided.
- iii. To put in place a deterrence/disclosure mechanism to curb misuse of delegated powers (both inherent and in consultation with IFAs).
- iv. To institutionalize a system of internal audit to verify the utilization of Inherent powers.
- v. To submit the report by **31 Dec 2015**.
